2.1. Subject to the terms below, the selection of specified residential properties will be divided into 3 (three) rounds applicable to the following 3 groups of persons who have already submitted their Registrations of Intent (each person a "Registrant"):

2.8 “Close relative” of an individual means a spouse, parent, child, parent-in-law, child-in-law, grandparent, grandchild and sibling of that individual **subject to the production on spot** of relevant supporting documents to the satisfaction of the Vendor to prove the such relationship. The Vendor reserves its right to accept or reject the request made by the Registrant and the Vendor's determination shall be final.

### 3. General Procedures

#### 一般程序

3.1 Interested persons may call 3705-9999 (hotline for the Development) for details of obtaining the form of Registration of Intent. The manner for the submission of the Registration of Intent and the documents and materials required, etc. are specified in that form. Please refer to the form of the Registration of Intent for details. The order of the submission of a Registration of Intent will not have any impact on the order of priority for selecting the specified residential properties. Generally:

3.2 In addition to copies of specified identification documents, each Registration of Intent shall be submitted together with cashiers' order(s). The number of cashiers' order(s) to be submitted shall be the same as the number of specified residential property(ies) the

Registrant intended to purchase as stated in that Registration of Intent. The amount of each cashiers' order shall be HK\$50,000. Each cashiers' order shall be payable to "Mayer Brown" or 「孖士打律師行」.

- 3.3 No more than one Registration of Intent applicable to these Sales Arrangements can be submitted by the same Registrant (a Registrant here means an individual, a company or a combination of individual(s) and/or company(ies) for the same Group. For the purpose of illustration, (1) a person A; and (2) that person A together with another person B will be taken as the same Registrant) in Group A1 and A2, and no more than two Registration of Intent applicable to these Sales Arrangements can be submitted in Group B

- 3.4 If Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued at any time between the hours of 7:00 a.m. and 8:00 p.m. on the date on which a Registration of Intent (Group B) may be submitted and/or at any time between the hours of 7:00 a.m. and 8:00 p.m. on the First Date of Sale, then, for the safety of the Registrants and the maintenance of order at the Designated Venue/Additional Venue, the Vendor reserves its absolute right to change the date(s) and/or time (including the closing date and/or time) for submission of Registration of Intent (Group B) and/or the First Date of Sale to such other date(s) and/or time as the Vendor may consider appropriate and/or to close the Designated Venue/Additional Venue.
